Nonaffiliates	Companies not related by common ownership and control. They can be financial or nonfinancial companies. ▪ <i>We do not share with nonaffiliates so that they can market to you.</i>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or service to you. ▪ <i>We do not jointly market.</i>
